The absence or presence of relevant financial and non-financial relationships with ineligible companies shall be disclosed to learners prior to all educational activities.

Activity content and resources shall be provided to CEPO in advance (as requested), reviewed, and edited accordingly, prior to the educational activity to ensure compliance with all accreditation standards.

Copyright Permissions: Faculty and/or content developers shall obtain the necessary copyright permission(s) for any portion of educational content that is not inclusive of their original work or for which they do not hold the copyright.

Standards of Professional Conduct: All persons who may influence educational content shall refrain from any manner of discrimination with respect to the material developed, released, or presented under this Agreement, including but not limited to, on the basis of race, color, ethnicity, national origin, age, sex, sexual orientation, religion, socioeconomic background, political affiliation, genetic information, veteran status, or disability consistent with all applicable laws, rules, and regulations.

Commercial Support and Commercial Bias: All persons who may influence educational content shall not receive any direct remuneration or gifts in support of accredited education from any non-government organization. Educational content shall not be subject to influence or direct input from any owner or employee of an ineligible company. Educational materials shall not include marketing. Promotion shall not occur during any educational activity.

Permission Acknowledgment: Materials developed for an educational activity may be duplicated and distributed to enhance participants' learning experience. Recordings and materials from live activities may be distributed as enduring material to expand access to individuals who may not have attended live.
