## 2025 NOV CCSS S04: Lessons from a Medical Readiness Journey (1.00 clock hour)

**Course Description:** This course explores the Geographic Combatant Commands (GCC), deployment medical eligibility criteria (MEC), and deployment limiting medical conditions (DLMC) that impact service members. Participants will gain a comprehensive understanding of the Department of Defense's medical readiness screening process and learn to apply data-driven tools to proactively address undetected medical eligibility issues. Through critical analysis, participants will also identify barriers to accurately measuring and enduring medical readiness.

- 4. Review the undetected DLMC dilemma.
- 5. Recognize barriers to accurately quantifying medical readiness.
