Course Description: This session examines the ethical debates and decision-making uncertainties surrounding resuscitation at extremely premature gestational ages. It further addresses the role of bias in clinical counseling and identifies evidence-based strategies to mitigate its impact on patient outcomes.

1. Describe the ethical debates surrounding resuscitation at extremely premature gestational ages.
2. Explore how uncertainty affects decision-making for these infants.
3. Recognize the potential for bias when counseling at extremely premature gestational ages and mitigation strategies.
