- Describe the opioid-related risk factors in the DoD LOT population, including risk factor trends from 2007-2017, demographic, geographic, and service-level factors associated with being high-risk, and a comparison of risk score calculators in determining high-risk.
- 3. Identify the effect of the CDC and VA/DoD guidelines on the proportion of LOT patients with >90 MEDD and the proportion of LOT patients with concomitant benzodiazepines.
- 4. Analyze the mission and vision & organization and programs of DHA Immunization Health care.
- 5. Comprehend the role of the IHS in your region.
- 6. Summarize the Continuous Quality Immunization Improvement Process (CQIIP) customer tool process, TSMP as it relates to vaccines, and the vaccine redistribution process.
- 7. Recognize which patients are eligible for Non-Formulary medications.
- 8. Discuss strategies to empower pharmacy staff to implement policies.
- 9. Discover how the provider order entry near miss documentation was internalized into the pharmacy prescription review process.
- 10. Evaluate how the data was collected, analyzed, and utilized to modify the provider order entry process and improve medication safety.
- 11. Demonstrate how the SharePoint based analytics platform allows for vertical and horizontal transparency of data across our organization.
- 12. Compare and discuss updates to the uniform formulary, including previous Pharmacy & Therapeutics (P&T) meeting clarifications, recent P&T drug class reviews, and placement of newly FDA-approved drugs.
- 13. Explain new changes to the current prior authorization (PA) criteria and utilization management (UM) updates, such as medication quantity limits (QLs) and medications added as line-extensions.
