### Behavioral Threat Assessment Through an Air Force Mental Health Lens (4.5 clock hours) 1200-1630 ET

### **Course Description:**

This training is intended for mental health providers across the Department of Defense and its purpose is to provide foundational training in behavioral threat assessment, recognized by the APA in 2013 as the gold standard of assessing threat cases. This training will bridge the gap between threatening individuals and how mental health providers can implement crisis intervention techniques to mitigate varying levels of threat concerns.

## **Learning Objectives:**

- 1. Interpret the Office of Special Investigation's (OSI) mission as it pertains to mental health, behavioral threat assessment, and crisis intervention techniques.
- 2. Explain clinical implications in behavioral threat assessment, management, and crisis intervention techniques.
- 3. Utilize empirically based factors from the mental health literature for the purpose of conducting a behavioral threat assessment and applying crisis intervention techniques.
- 4. Review privacy laws, ethical guidelines/standards, and their exceptions in the context of behavioral threat assessment and crisis intervention techniques.
- 5. Organize resources available to employ threat mitigation, management strategies, and crisis intervention techniques.
