2. Distinguish between typical stress reactions vs. clinical disorders that should be referred for assessment and intervention.

3.Apply the Open Questions, Affirmations, Reflective Listening, and Summaries (OARS) acronym to generate Motivational Interviewing (MI)-consistent verbal behavior.

4. Discuss how MI emerges from a collaborative 'spirit', use of OARS, and deliberate evocation.

5. Describe the different ways in which "functioning" is understood depending on the population being treated and the health concerns involved.

6. Identify interventions that the literature has indicated are effective for improving functioning in multiple patient populations.
