8. Explore the mechanisms by which cell signaling properties can bring forth maturation.
9. Describe orthognathic surgery's role in orthodontics.
10. Evaluate the impact of orthodontic and surgical interventions on esthetics.
11. Examine the bi-directional relationship between periodontics and orthodontics.
12. Assess periodontal considerations at different stages of orthodontic treatment.
13. Describe the different components of a computer-aided design/computer-aided manufacturing (CAD/CAM) workflow.
14. Analyze the accuracy of digital scanning compared to conventional workflows.
15. Identify the causes for nerve trauma.
16. Discuss treatment options for nerve trauma.
