7. Delineate the responsibilities of the Occupational Hearing Conservationist and Professional Supervisor for follow-up audiometric monitoring
8. Describe the critical role occupational and environment medicine physicians play in the prevention of occupational noise-induced hearing loss (NIHL)
9. Describe factors that affect hearing protector attenuation and influence hearing protection fit
10. Correctly evaluate employee records for noise exposure and inclusion in a hearing loss prevention program
11. Establish Key Performance Indicators for all aspects of the hearing conservation program
