- 10. Bridge the knowledge gap of what "ideal" wound care looks like and how to creatively modify this in a downrange scenario.
- 11. Apply acquired knowledge to perform burn wound debridement and dressing placement.
- 12. Explain how to provide burn shock resuscitation fluids in a safe and effective manner preventing under and over resuscitation.
- 13. Describe the treatment strategy for inhalation injury.
- 14. Differentiate the clinical presentation of burn sepsis versus sepsis in a non-burn patient.
- 15. Discuss tools used to evaluate pain, sedation, and delirium in a critically ill patient.
- 16. Discuss the metabolic response to thermal injury/trauma.
- 17. Describe the evaluation and management of thermal ocular burns
- 18. Summarize the different surgical procedures and utilization for scar reconstruction.
- 19. Describe clinical situations in which requesting Maxillofacial Prosthetics support in multidisciplinary care can improve patient quality of life, improve outcomes, expedite healing, and reduce need for additional surgery.
- 20. Describe the two types of wound healing and their relevance to contracture.
- 21. Describe the psychological impact of burn injury in burn and multiple trauma survivors.
- 22. Summarize the six stages of the Progressive Return to Activity (PRA).
- 23. Mitigate moral distress from difficult decision-making.
